- If all requirements are already satisfied and you can supply a GA Department of Agriculture License, you may provide that number here. # _____
- All sampling forms must be submitted at least 14 days prior to the Cobb Galleria Centre (services@cobbgalleria.com).
- If you are preparing food while on Cobb Galleria Centre property, you must complete the *Cooking Authorization Form*.
- Failure to complete and submit all required paperwork will result in the ceasing of cooking and food distribution operations.

GUIDELINES FOR FOOD DISTRIBUTION & SAMPLING OPERATIONS

- Any food or beverage items dispensed while on property is considered "sampling."
- Food centric events and/or tradeshows are not required to complete this form. Please see the explanation below to determine exempt events.
 - "Large-scale events that showcase food and beverage products. Any business opportunity where food manufacturers, producers, distributors, or other retailers come together to show case food and other consumable items."
- Companies or organizations may only distribute samples of food and/or non-alcoholic beverage products that the providing company or organization produces or sells during normal business operations.
- Samples may only be distributed in such quantities that are reasonable to promote merchandise.
- Sample items are limited to products manufactured by or licensed for distribution by exhibiting companies and must be related to the purposes of the tradeshow.
- All items must be "sample size portions."
 - Food items must be "bite size."
 - Beverages are limited to 4 oz.
 - Bottled Water (regardless of size) is prohibited. All exhibitors wishing to disperse bottled water must place an order with Cobb Galleria Centre's Food & Beverage department.
 - **Absolutely no alcoholic beverages**
